Weingarten Rights

You have the right to union representation if you are called to a meeting with management that could lead to discipline.

The employee must make a clear request for union representation either before or during the interview. Managers do not have to inform employees of their rights. Management cannot retaliate for requesting representation. Management must delay questioning until the union steward arrives. It is an unfair labor practice for management to deny an employee's request for a steward and continue with interrogation. In this case, an employee can refuse to answer management's questions.
